- Aquatics has begun to winterize the outdoor pool. Operations put away the sails and Parks is winterizing the lawn and getting it prepared for Winter.
- Matt Clark has been hired as the new Head Water Polo Coach. He played Water Polo for Cottonwood High School and swam for CHAT. He played college Water Polo at the Air Force Academy and also University of Utah. He has also coached at Cottonwood Heights, Jordan High School and Cottonwood High School. A parents meeting was held on October 10. On Friday October 18 a scrimmage was held. Clinics have been set up for November 2 and 9 from 10 am to Noon.

Recreation and Fitness Report

Mr. Warren Hallmark presented the Recreation and Fitness Report:

- Fall Flag Football has 112 participants. The Games are played at Mill Hollow Park.
- Fall Biggest Loser has 22 participants.
- Learn to Play and Learn to Skate have begun.
- Monster Mash will be October 25 from 5-7pm in the gym/ice rink in continued partnership with CH City.

Parks and Facility Maintenance Report

Mr. Ryan Gardner presented the Parks and Facility Maintenance Report:

- Visual Maintenance continues to complete daily and nightly duties while
 preparing for the increased workload created by the Fall and Winter seasons. Due
 to the success of the last "Sunday Blitz" another session was scheduled for
 October 13th. The areas included deep cleaning all carpeted areas on the ice
 balcony, washing racquetball court walls and floors and sanitizing the spin room
 mats
- Operations has winterized the outdoor pool and pool deck. The department is also working on finalizing their 2019 Department Goals, one of which is labeling all gas lines, steam lines, water lines and tagging all valves throughout the building.

- Other projects include converting the lights in racquetball court #3 to LED, replacing the splash zone pool chlorine tank and replacing the back-up system for the lights in the ice rink and main lobby.
- Parks: The parks department is in the process of closing the parks for the season which includes pruning trees and shrubs, cutting back perennials, removing annuals and shutting off the water supply to the irrigation systems and bathrooms. The parks will continue to be watered weekly until the third week of October. The last week of October and first week of November will be used to blow out the irrigation lines with compressed air and winterize all restrooms except for Mt. View. The snow removal equipment has been serviced. A new UTV equipped with a snow removal package has been purchased using credit received from an old unrepairable UTV. Ryan is in the process of drafting a new Landscape Maintenance/Snow Removal Contract between the Service Area and Cottonwood Heights City. He is also working on a new updated, comprehensive maintenance log to ensure proper care and routine maintenance of all Service Area vehicles.
